ADV PRODIGY AD PRESENTED CONSOLIDATED INTERIM FINANCIAL STATEMENTS FOR THIRD QUARTER OF 2009

For the period 01.01.2009 – 30.09.2009 the Group has realized income from sales of services at total amount BGN 1,932,000.00. The Group has accumulated operating expenses at amount of BGN 1,757,000.00. According to the Consolidated Interim Financial Report as of 30.09.2009 of the Group that Advertising Prodigy AD belongs, the financial result as of 30.06.2009 is profit at amount of BGN 190,000.00

THE CAPITAL INCREASE PROCEDURE OF ADVERTISING PRODIGY AD IS COMPLETED

On 10.11.2009 with record 20091110100955 in the Commercial Register, was announced the current Statute of ADVERTISING PRODIGY AD, in accordance with the decision taken at the additional General Meeting of Shareholders, held on 17.10.2009.

In accordance with the submitted application of ADVERTISING PRODIGY AD to the Financial Supervision Commission, FSC took a decision with record 937-E from 18.11.2009 for listing subsequent emission of shares for BGN 360,000.00, distributed in 360 000 ordinary, dematerialized, with a vote right shares with 1 BGN nominal value per share, in accordance with the increase in the capital of the Company from BGN 360,000.00 to BGN 720,000.00.

At its meeting held on 03.12.2009, the Board of Directors of BSE-Sofia decided to admit the additional issue of shares of Advertising Prodigy AD for trading on the Unofficial Market of Equities. The date, 11.12.2009 was the beginning date for executing transactions with the shares from the increase of the capital.

STOCK PRICE FLUCTUATION

The market value of the share at the moment is 4.60 BGN and the capitalization is BGN 3,261,600.00 (last trading date 03.12.2009).
